# <u>Post Office Horizon scandal - another</u> <u>shockingly dishonest scandal</u>

I enjoyed a proud moment in Parliament earlier this month when I had an opportunity to sit down and talk with inspirational Horizon scandal campaigner Jo Hamilton. We talked about her experiences and how a Hillsborough Law would make a real difference when fighting for truth and justice.

It is now clear that evidence of the widespread problems with the Horizon IT system were withheld from disclosure at the numerous prosecutions brought by the Post Office against the sub-postmasters.

Hillsborough campaigners have for many years been calling for a Hillsborough Law that would introduce a 'duty of candour' that would compel public officials to tell the truth at public inquiries and inquests as well as establishing an offence of recklessly or intentionally misleading the public, media, or court proceedings.

The Post Office scandal shows why a Hillsborough Law is absolutely critical. In broad terms a 'duty of candour' should force managers and their lawyers to think twice before acting dishonestly. At present they can get away with it because such dishonesty would not see the light of day.


A full Hillsborough Law would also have required Post Office managers and lawyers to identify issues with the pilot scheme at the outset of investigations and not stay silent whilst waiting to see whether it would be discovered. Senior Post Office officials would be forced to think twice because under a full Hillsborough Law they would be committing an offence if they wilfully withheld information. It would also embolden honest staff in public authorities to whistle-blow.

This is why we are campaigning for a full Hillsborough Law, which includes a Statutory Duty of Candour, to compel all public servants to tell the truth in order to protect ordinary members of the public.

Whilst it is shocking that we need a law to ensure that public servants are honest in this country, the simple fact is that we do.

As we have seen with tragedies such as Hillsborough, Contaminated Blood, Nuclear Test Veterans, Grenfell, Manchester Arena Bombing and the Post Office Horizon scandal, Government and public bodies all too often have to be forced and shamed into revealing the truth.

And this will keep on happening unless we make it much harder for those in power to cover up their actions or those of others.



# Devastating report on Liverpool's public health inequality

"People living in the most deprived areas of Liverpool currently live an average of 15 years less than those in the most affluent parts and live 18 years longer with poor health".

That is just one of several shocking findings from a sobering report published by Liverpool's Director of Public Health Professor Matt Ashton, which paints a grim picture of the horrendous scale of health and homelessness problems in our city and the enormous challenges facing 'Dickensian' Liverpool.

In his landmark report, Professor Ashton spells out some of the shocking health statistics already facing Liverpool and shows how

much worse things could get if urgent, comprehensive action is not taken. The devastating report shows that:

- People living in the poorest areas of the city, such as Tuebrook here in our constituency, live an average of 15 years less than people in the most affluent areas and live 18 years longer with poor health.
- Residents in the most deprived areas of the city are also living with major illness (two or more long-term conditions) around 10-15 years earlier than those in the most affluent.
- Infant mortality rate remains above the national average and each year in this city, 26 babies do not reach their first birthday an horrific statistic, I'm sure you will agree.
- Around 1,900 residents die young (under the age of 75) with 1,100 of these deaths being preventable.

Austerity from this Government has caused untold harm, poverty and deprivation to the health and wellbeing of so many in this constituency and city. We need radical solutions like a Right to Food enshrined in law and massive investment in our communities to repair the damage caused by Government cuts to welfare and local government since 2010. It is unforgiveable and I trust our city to remember this at the General Election.


### Sir Tony Lloyd MP (1950 – 2024)


# **Debates, Votes & Oral Questions**

# My Westminster Hall debate on free school meals for children with special educational needs and disabilities

164,000+ children with special educational needs and disabilities are currently denied access to their free school meals. This month I called for and led a debate in Parliament to demand an end to this injustice and to raise the campaign work of my constituent Irene, Contact, the charity for families with disabled children, and campaigner Natalie Hay.

Ahead of the debate I explained why I had called for it: "Seeing the scale of the problem shocked me to the core. Parents, Contact charity and other campaigners should not have had to fight this hard and for this long... We've seen in regard to the Post Office Scandal how quickly Government can act when the political will is there. So I sincerely hope the Schools Minister will give his assurance that the Government will act swiftly on this issue too."

# **Levelling Up, Housing and Communities Questions**

I called on the Secretary of State, Michael Gove MP, to extend the household support fund beyond March 2024. The household support fund has supported 330,000 households in Liverpool since its introduction. Like many other councils, Liverpool City Council says the fund will need to continue beyond March 2024 to keep residents well supported, to stay in and enter work, and to prevent an escalating crisis.

## Voting against the Government's Rwanda Bill

On 17 January I voted against the Government's immoral Rwanda Bill (Safety of Rwanda (Asylum and Immigration) Bill). I am utterly opposed to the Government's policy of deporting asylum seekers to Rwanda. Refugees didn't create the NHS crisis. Refugees didn't create the housing crisis. Refugees didn't create austerity, the Tories did - and now they want a scapegoat. Plans to deport asylum seekers to Rwanda before their claims have been heard have been condemned by national and international organisations that defend human rights, anti-racist campaigners, religious groups and the United Nations High Commission on Refugees (UNHCR).

# Voting for Labour's plan to boost NHS dentistry

The lack of access to NHS dental services is having a profound impact on the health and wellbeing of residents in West Derby. On 9 January I voted for Labour's plan to boost NHS dentistry with 700,000 more appointments a year and for a targeted dentist recruitment scheme to end dental deserts. The Tories voted it down.

# Voting Against the Economic Activity of Public Bodies (Overseas Matters) Bill

On 10 January I **voted against the Government's Bill.** A group of over fifty civil society organisations and trade unions have signed a collective statement calling for an immediate halt to the *Economic Activity of Public Bodies (Overseas Matters) Bill*, which they argue will "stifle a wide range of campaigns for justice, erode local democracy, and present a threat to freedom of expression".

### The right to a Mould Free Home

I see the devastating impact of damp and mould on many constituents. This month I have been supporting Fleur Anderson MP's Bill to extend Awaab's Law, which forces social landlords to fix damp and mould within strict time limits, to privately rented homes.



# Campaign for end to 'guilt by association'

I was delighted to support Kim Johnson MP's Bill this month to end the injustice of 'joint enterprise' law. Kim's Bill would end guilt by association to ensure only those significantly involved in a crime are convicted. This would help to stop many injustices.



#### Infected blood scandal

This month I joined more than 100 cross-Party MPs & Peers in calling for the same urgency to be shown to those impacted by the infected blood scandal as has finally been shown to those involved in the Post Office Horizon scandal.

#### **Food and Work Network event**

It was a privilege to bring this group, created eighteen months ago, to Parliament this month to hear some excellent contributions from across the Right To Food movement on why our campaign must remain at the top of the national political agenda until it is delivered. Special thanks to BFAWU and NEU unions for their contribution.

## **Brain tumour research**

I tabled Written Questions to the Secretary of State for Health and Social Care about current levels of Government funded brain tumour research. Historically just 1% of the national spend on cancer research has been allocated to this devastating disease and I fully support the Brain Tumour Research Charity in their campaign to change this.

# Support for young people with cancer

I tabled Written Questions to the Secretary of State for Health and Social Care regarding what steps the Government is taking to reduce waiting times for the diagnosis and treatment of cancer in young people. It was a privilege to meet with the Teenage Cancer Trust in Parliament recently and I will continue to call on the Government to provide the funding and resource that is needed to improve diagnosis and treatment for young people will cancer.

## **New dementia treatments**

I tabled Written Questions to the Secretary of State for Health and Social Care about new dementia treatments. Alongside investing in new treatments and research, the Government must push up stagnating dementia diagnosis rates and reduce variations in the standard of care. I will

continue to hold the Government to account by calling for the proper scale of intervention and funding needed to support everyone who is affected by dementia.

# **Screening for liver diseases**

I tabled Written Questions to the Secretary of State for Health and Social Care about improving NHS screening for liver diseases.

## **Child poverty in West Derby**

It is horrific that more than 8000 children in our West Derby constituency are living in poverty as a result of this failed Government's political choices. I started this year by writing to the Secretary of State on the 2nd January to demand action to eradicate child poverty here and across the UK.

#### RE: Child Poverty in Liverpool West Derby

I would like to draw your attention to <u>research</u> from The End Child Poverty Coalition at Loughborough University, which details the levels of child poverty in each constituency across the UK.

I feel compelled to write to you to hammer home the sobering statistic that 8233 children – nearly 40% - in my constituency of Liverpool West Derby are living in poverty. This has increased by 6.9 percentage points since the middle of the last decade.

Most strikingly of all, the report found that across the UK the poverty rate for children in families with three or more children was 42%, compared with 23% and 22% among children in families with one or two children, respectively.

There is a clear correlation between the decisions made by government and the lives and development of young people in your constituency and in mine. It is clear that one of the most effective ways to begin to reduce child poverty would be to scrap the two-child limit to benefit payments. This would lift 250,000 children out of poverty, and a further 850,000 children would be in less deep poverty at a cost of just £1.3 billion.

I, along with a number of MPs from across the House of Commons, have signed a Parliamentary Motion (Early Day Motion 1481) that "opposes the continuation of the cruel and unnecessary two child limit for benefits, introduced by the Government in 2017". We call on your Government to scrap "the two child limit and [note] that the current Government has overseen a huge increase in child poverty since 2010, with a majority of children living in poverty in households where at least one adult is in work".

As you will know, another way to ensure children avoid poverty in their early years — especially food poverty—is to ensure they receive a nourishing free breakfast and lunch in school. Too many of our young people do not have access to free school meals even though they would clearly benefit. Analysis by the Child Poverty Action Group (CPAG) shows that children in poverty in England continue to be overlooked by government measures, with over 1 in 3 (800,000) children in poverty not qualifying for free school meals.

There is abundant evidence to suggest that proactive investment in young people isn't a "spending commitment" that must be financed but a net saving down the line. I have called on numerous Ministers since I entered Parliament to introduce universal free school meals for all primary and secondary pupils in England. I believe the benefits are manifold and as with the two-child benefit cap, what appears to be lacking is the political will.

I also agree with the sentiments of the Trade Union Congress that universal free school meals "must be just one part of a strategy for reducing child poverty. That strategy must tackle issues of insecure work, low pay, and inadequate social security, soaring housing costs, unaffordable and accessible childcare, which leave so many children and families struggling to survive".

In light of the figures from the End Child Poverty Coalition, what reassurance can you offer me that the government takes seriously the lives of the young people I represent? What steps is the government taking to end child poverty and what consideration has been made to including universal free school meals and ending the two-child benefit cap in such a plan?

Dear Secretary of State

I write to you today in my capacity as Chair of the Public Accountability All-Party Parliamentary Group (APPG) which backs the campaign for a full Hillsborough Law, including a statutory Duty of Candour to compel all public servants to tell the truth in order to protect ordinary members of the nublic

I am sure you agree how shocking it is that we need a law to ensure that public servants are honest, but the facts show that we do. We have seen in the cases of so many tragedies, including but not limited to, Hillsborough, Contaminated Blood, Nuclear Test Veterans, Grenfell, Manchester Arena Bombing and the Horizon Post Office scandal, that Government and public bodies all too often must be forced and shamed into revealing the truth.

Secretary of State, the Horizon Post Office scandal and cover-up appears to be yet another shockingly dishonest scandal. This issue has been brought to the fore of the public consciousness, as you are well aware, via the recent ITV drama Mr Bates vs The Post Office. The anger and shock felt by the public in response to the appalling treatment of so many sub-Postmasters is palpable and I note that Government has announced an urgent response to this massive miscarriage of justice. These measures are of course to be welcomed and Government's response highlights just how swiftly and decisively Government can act when it chooses to.

With this in mind, it is imperative that if Government is serious about ensuring this kind of appalling scandal can never happen again, that it commits to implementing Hillsborough Law in full as soon as possible. Secretary of State, these scandals will keep on happening unless we make it much harder for those in power to cover up their actions or those of others. With this in mind, what I would specifically like to raise with you, in relation to the Horizon Post Office scandal, is how it perfectly highlights the need for a full Hillsborough Law that includes a Statutory Duty of Candour, which Government has so far refused to implement:

- With a full Hillsborough Law on the statute books, a legal Duty of Candour would have made Post Office officials and their lawyers think twice before acting dishonestly. At present people in public roles can get away with it because such dishonesty would never see the light of day
- A full Hillsborough Law in place would have also required Post Office managers and lawyers
  to identify the issues with the pilot scheme at the outset of investigations and not stay silent
  whilst waiting to see whether it would be discovered.
- Senior Post Office officials would be forced to think twice because under a full Hillsborough Law they would be committing an offence if they wilfully withheld information.

# **Committee Work:**

I am a Member of two House of Commons Select Committees: *The Levelling Up, Housing and Communities* and *the Environment, Food and Rural Affairs Committee*. As a Committee member, I scrutinise Government policy and hold them to account through a process of evidence sessions and inquiries.

## **Environment, Food and Rural Affairs (EFRA) Committee:**

As part of our Inquiry on Fairness in the Food Supply Chain, we questioned witnesses from the food industry, including trade union representatives. We heard powerful testimony from Sarah Woolley, General Secretary of the Bakers, Food and Allied Workers Union, who described the conditions faced by workers in the food industry. She said: "Our sector is blighted by endemic low pay, zero-hours contracts, short term and temporary agency work and obviously, as has been touched on, the exploitation of migrant workers. It is deemed as a low-skilled sector, but I wonder how many colleagues in the room today could identify a faulty machine just by the sound of it. I


wonder how many could stand and make 60 sandwiches an hour like our members do in certain places".

I will continue to campaign alongside the trade unions for the improved pay and conditions that food industry workers in West Derby, and across the country, deserve.
