In Parliament

Parliamentary and Health Service Ombudsman (PHSO) ruling on Pensions injustice

The PHSO report last week acknowledged that the blame for the pensions scandal that has terribly impacted on nearly four million 50s-born women lies squarely at the feet of the DWP. But the women I spoke to in West Derby rightly feel utterly insulted by the amount of recommended compensation. Many have been plunged into poverty through no fault of their own. I will continue to fight for justice for 50s-born women. #WASPI #50sWomenFullRestitution

Small victory as Household Support Fund is extended - Spring Budget

A small victory this month with the announcement from Government that the Household Support Fund will be extended for a further six months. This is, of course, not nearly long enough and I will continue to fight for this funding. Thanks to all campaigners who have fought for the continuation of the Household Support Fund and to the 35 MPs who have signed my Parliamentary Motion on this issue. The fight continues to retain this crucial support for struggling families.



Famine in Gaza is a human-made catastrophe

Back in January I asked the Government if they believed Palestinians have a Right to Food. No meaningful action ensued. This month the UN stated that Israeli restrictions on humanitarian aid into Gaza, causing mass famine, may constitute the war crime of deliberate starvation. UN Security Council finally demands an immediate ceasefire in Gaza

I have consistently called for a ceasefire in Gaza and I agree wholeheartedly with the Secretary-General of the UN, António Guterres, who this week said: "The Security Council just approved a long-awaited resolution on Gaza, demanding an immediate ceasefire, and the immediate and unconditional release of all hostages. This resolution must be implemented. Failure would be unforgivable."

Debates, Votes & Oral Questions

Debates

<u>Update: Debate on access to free school meals for children with special educational needs and disabilities</u>

164,000+ children with special educational needs and disabilities are currently denied access to their free school meals. In January I called for and led a debate in Parliament to demand an end to this injustice and to raise the campaign work of my constituent Irene, Contact, the charity for families with disabled children, and campaigner Natalie Hay.

I am thrilled to report that the new Department for Education Free School Meal Guidance March 2024 was published this month. Thanks to the hard work of Contact, campaigners and families in West Derby, guidance now includes a section on making reasonable adjustments for disabled children, such as by offering a food voucher. It also clearly sets out expectations on what schools should do to comply with the Equality Act 2010 in the delivery of school lunches.

More than 160,000 disabled children will be able to finally to access their free meal school entitlement and many of their families will no longer have to worry about food insecurity or rely on food banks to feed their children.

Thank you to Contact and everyone involved in this campaign to ensure equal rights for disabled children. This will make a huge difference to many families in West Derby.



12 March: Debate on compensation for women affected by state pension changes

I spoke of my ongoing support for the 5,360 1950s-born women in West Derby who have been affected by the changes made to the women's state pension age. More than 3 million women in the UK have been left in what I believe is an entirely unacceptable situation as part of this historic wrong. In the debate I said: "This is an injustice that needs to be addressed urgently. It is completely unacceptable that the Government have so far refused to take action to right this wrong. There is nothing to stop the Government taking immediate action to provide compensation, as has been outlined in this place today." I asked the Government minister "to begin the parliamentary process to provide the full compensation that thousands of women in West Derby and millions across the country deserve, without delay".

11 March: Debate on the Government's Spring Budget

I heard nothing in the Government's Spring Budget, announced by the Chancellor on 6 March, for the 14.4 million people, including 4.2 million children, who are living in poverty in the UK. There was nothing in his Budget for social care, which is on its knees, or for social security - at a time when poverty and homelessness are rising.

This Budget was the latest in more than a decade of austerity budgets which have hollowed out our vital public services and have increased the deep wealth inequalities in our supposedly wealthy country.

In my speech in the House of Commons I highlighted that there was nothing in the Budget that will reassure parents, pupils, teachers or trade unions that the Government understands the crisis in our schools and colleges.


I said: "There was nothing for education, at a time when one in five teaching assistant posts is unfilled and the Government have missed their overall teacher recruitment target for more than three years". "Last week I visited three schools in my constituency, and saw the magnificent efforts of the teaching teams to not just educate, but keep families afloat in my community, given the Government's absolute failure to do that...They deserve a Government who will invest in their future, not double down on austerity."

06 March: Debate on Kinship Care Strategy

I spoke on the economic hardships facing kinship carers and paid tribute to the kinship charter developed by Pauline Thornley of Kinship Carers Liverpool. I urged the Government to legislate to provide financial support to kinship carers in the same way as is provided for foster and adoptive parents. 28 February: Debate on digital exclusion

I spoke about the impact of years of austerity on our public services and on people in West Derby and across the country who are struggling to access online public services, including digital NHS services and Universal Credit, and who are unable to access online banking. I told the House of Commons that all public services must offer and promote an affordable, easy-to-access and offline way of using them – and that banks must provide face-to-face services in West Derby. I also reiterated my strong belief that broadband is an essential utility and that it should be made free and available to all as a universal public service.

Events special focus:

Supporting Lloyd Russell-Moyle MP's Bill to #BanConversionTherapy

It was a privilege to be in Parliament on 1 March to support my colleague Lloyd Russell-Moyle MP's Bill to #BanConversionTherapy and listen to his fantastic contribution in the chamber. Thank you to the many constituents in West Derby who were in touch with me about the debate.

"Conversion therapy" refers to any form of treatment or psychotherapy which aims to change a person's sexual orientation or to suppress a person's gender identity. It is in my view, and the view of health experts and LGBTQ+ campaigners, harmful and unethical.

The NHS and all major UK counselling and psychotherapy bodies have also concluded that conversion therapy is dangerous and have condemned it by signing a Memorandum of Understanding. The United Nations (UN) official Independent Expert on this issue has said that conversion therapy can amount to torture and called for the practice to be banned.

I am opposed to all forms of LGBTQ+ conversion therapy and will continue to call for Government to introduce legislation so that it is made illegal with no more delays and no loopholes.



Parliamentary Written Questions:

Protecting people in Gaza and the West Bank

I asked the Government a series of questions about what it is doing to enable the delivery of supplies into Gaza, and to ensure the protection of people there and in the West Bank.

I have also continued my calls in Parliament for an immediate ceasefire.

Endometriosis Action Month

March is Endometriosis Action Month. Many who experience endometriosis speak about having a long road to effective diagnosis, experiencing barriers to treatment and pain management, and a lack of support in their workplace. On behalf of all those with Endometriosis in West Derby I asked the Health Secretary what action and funding will be given to improve diagnosis times and to improve care.

Accessible homes for private renters

19% of disabled people live in the private rented sector, yet shockingly, the EHRC estimates that 1 in 3 disabled people in private rented properties live in unsuitable accommodation. Following powerful evidence given to Parliament by Disability Rights UK I asked the Government for more information about the number of issues. I asked for information on how many wheelchair-accessible homes have been built in the past year; how many Disabled Facilities Grants distributed to private rented sector tenants last year; and how many disabled people were evicted thorough section 21 no-fault evictions in the private rented sector in 2023.

Protection of mothers and babies from Strep B

I asked the Health Secretary what action her department is taking to protect mothers and babies from the impact of Group B Streptococcal Infection.

Improving dementia diagnostics

Almost one million people in the UK are currently living with dementia – a figure which is likely to increase to 1.6 million by 2040. It is vital the Government pushes up stagnating dementia diagnosis rates, reduces variations in the standard of care and improves system readiness for new treatments. I asked the Health Secretary several questions about what action and funding she will put in place to do this.

Parliamentary Letters

Impact of energy bills on disabled people

I wrote to the Government's Secretary of State for Energy Security and Net Zero on behalf of many disabled constituents who are experiencing fuel poverty in West Derby. In my letter I call on the Government to work directly with disabled people and charities to tackle the inequality of extra costs – and to respond to the calls of the charity, Scope, to bring in a discounted energy bill scheme.

Events at Manchester United

LFC fans, including Hillsborough survivors and families of the 97, are appalled by "tragedy chanting" by some Manchester Utd fans at the recent fixture. Education is key and I have written to MUFC to invite them to work with our Real Truth Legacy Project team. The Real Truth Legacy Project was started in September 2021 to ensure that *the real truth* of Hillsborough is taught across all age groups so that lies and smears about the disaster propagated by the media and state agencies are eradicated forever. Events at Everton FC and the need for an Independent Football Regulator

Many constituents in West Derby have been in touch with me about the events at EFC. More than two years have passed since the fan-led review of English football found that we required independent scrutiny and legislation. Earlier this month I wrote to the Secretary of State to urge the Government to immediately introduce an independent football regulator to safeguard the future of the game:

UN Special Rapporteur on the Right To Food

It is now 15 months since the UN Special Rapporteur on the Right To Food Michael Fakhri said he would like to undertake a formal visit to the UK. I have written to the Prime Minister to ask when this visit will take place. This month new data revealed that there's been a staggering 68% increase in one year in the number of people who don't have enough food. We need a #RightToFood enshrined in UK law.

It was a real honour to speak at Old Trafford on behalf of the Committee at a seminar about our inquiry into urban green spaces. There were so many fantastic contributions from many stakeholders on the importance of green spaces.

Disabled people in the housing sector

As part of the Committee's inquiry into the experience of disabled people in the housing sector. I asked a D Department for Levelling Up, Housing and Communities how we can ensure that it's not a postcode lottery have access to a wheelchair-accessible home.

I also asked how Government responds to local authorities not meeting this need. Several submissions to our in Government to mandate 10% of new-build homes to be Building Regulation M4(3) compliant (fully wheelchair as I asked the Minister if the Government plans to do this.





The Real Truth Legacy Project


