In Parliament

Human rights in Palestine

A large number of West Derby constituents contacted me specifically about votes in the House of Commons on 15 November 2023 and on 21 February 2024.

In November 2023 I voted for amendment 'h' to the King's Speech which supports calls for an immediate ceasefire. This amendment, in the name of Stephen Flynn MP, expressed "that there must be an end to the collective punishment of the Palestinian people", called "for the urgent release of all hostages and an end to the siege of Gaza to allow vital supplies of food, fuel, medicine and water to reach the civilian population" and called "on the Government to join with the international community in urgently pressing all parties to agree to an immediate ceasefire." Unfortunately not enough MPs joined me in voting for this amendment and it was therefore defeated.


I can also confirm that on 21 February 2024 I would have voted once again, as I did in November, for an immediate ceasefire. The chaos that surrounded the SNP's Opposition Day Debate in Parliament was unsavoury and served to distract from the desperate situation in Gaza.

A large number of West Derby constituents have also contacted me to ask me to sign Parliamentary motions, namely Early Day Motion #1685, Early Day Motion #1 and Early Day Motion #377. I can confirm that I have signed all of these Parliamentary motions.

More than half of people receiving UC cannot afford enough food

This month the Trussell Trust has reported that in January, more than half of people receiving Universal Credit were unable to afford enough food - and 780,000 people receiving it visited a food bank for support at least once in the last month.

This is disgraceful. Food banks are doing all they can to support people but, as we know, they are a sticking plaster and the systemic change that



we are working for with the **<u>Right To Food campaign</u>** is what is desperately needed in the longer term.

In the short-term, however, the Chancellor must take urgent action in the Spring Budget to increase long-term support for people on Universal Credit.

He must also extend the Household Support Fund - and you will see further down in this report that this month I have tabled an Early Day Motion in support of this essential funding being extended.

Palestinians have a Right to Food

This month in Parliament I raised the fact that Palestinians have a Right To Food, after the United Nations Special Rapporteur on the Right To Food, Michael Fakhri, said at the weekend that more than 2 million people in Gaza are facing "inevitable famine". Now that the Government has opted to halt its funding to the UN Relief and Works Agency for Palestinian refugees, I asked how it now plans to ensure that urgently needed humanitarian aid - as called for by the International Court of Justice - will continue to be delivered to the children, women and men in Gaza. Health and Social Care Questions

Many West Derby NHS staff have written to me and expressed concerns about the classification and regulation of NHS medical associate roles and patient safety. On 23 January I raised this in the House of Commons. I told the Government Minister for Health and Secondary Care, Andrew Stephenson MP, that "NHS staff have expressed concerns about the Anaesthesia Associates and Physician Associates Order 2024" and asked him "if resource will be needed for AAs and PAs to be properly supervised by doctors on a one to one ratio?" and furthermore if he would "meet trade unions and professional bodies as a matter of urgency to clarify the Government's position on this hugely important public health issue?".

Parliamentary Written Questions:

Medication shortages:

Constituents have been in touch with me about the impact that medication shortages are having on them. I have been submitting Written Parliamentary Questions to the Health Secretary in order to get answers on what is causing shortages of some medications, and to push for supplies to be increased.

Treatment of Seasonal Workers:

I tabled Written Parliamentary Questions to the Home Secretary about the appalling conditions faced by seasonal workers at farms across the UK. This follows revelations by the Bureau of Investigative Journalism (TBIJ) that hundreds of migrant workers in the UK's agriculture sector have raised welfare issues about poor conditions, pay and treatment, including wage theft and racism.

RE: Measures relating to homelessness and rough sleeping in the Criminal Justice Bill

I am writing to you to share the attached correspondence which I have received from a number of constituents in Liverpool West Derby regarding the Criminal Justice Bill.

Like many constituents, I am appalled that the Criminal Justice Bill contains fourteen separate measures relating to sanctions the government proposes to impose on people who are rough sleeping. Most significantly the Bill makes a number of provisions regarding "rough sleeping prevention notices" and proposes to make it an offence for a rough sleeper to fail to comply with such a notice. Committing the said offence would carry a possible jail sentence or large fine.

I agree with the words of homelessness charity, Crisis, who have said that: "Poverty pushes people into homelessness and the fact that homelessness exists in 2024 is a failure of Government policy. This Bill would criminalise and dehumanise those of us that have been failed by a system that should keep all of us safe. We should treat people who are homeless with dignity and humanity – not with the threat of police action."

You will no doubt be aware of the escalating homelessness crisis across the country and that local councils are facing enormous challenges in order to meet their statutory duties to provide temporary and emergency accommodation.

The devastating scale of the homelessness situation in Liverpool has led the City Council to write twice to your colleagues in the Department for Levelling Up, Housing and Communities to declare an emergency and calling for emergency funding. One of the main drivers of the crisis is the use of Section 21 evictions, the repeal of which has been kicked into the long grass by the Government despite many promises.

I therefore horrified that the government's main ambition appears to be to criminalise homelessness rather than addressing its structural causes, empowering local authorities to provide tailored support and increasing the supply of affordable and good quality housing.

In the attached correspondence my constituents are calling on you, in your role as Secretary of State, to immediately enact the repeal of the Vagrancy Act 1824 and remove the parts of the Criminal Justice Bill referring to rough sleeping and begging as they will criminalise homelessness.






Right To Food Campaign in Scotland
